Low-income families with children are also disparately impacted by the lack of affordable housing in thriving communities across the U.S. People of color comprise a significant portion of the poorest families, paying more than half of their income for rent and utilities. According to the U.S. Census Bureau, over 40% (19 million) of renter households in the U.S. spent more than 30% of their income on housing costs during the 2017-2021 period, leaving too little for other necessary expenses including transportation, healthy food and medical care.

In many communities across the country, people of color, including families with children,
